The Program provides a third-party guarantee of a Builder Member's warranty obligations and undertakes to backstop those obligations should the Builder Member be unable to fulfil those obligations. Builder Members register all eligible homes with the Program.

All Registered Builder Members have satisfied the Program's rigorous membership criteria which includes, technical expertise, a proven track record, financial stability, and high standards of Customer Service. ## Warranty Coverage Details

### Premier Coverage (1-2-10)

#### DEPOSIT COVERAGE

The initial deposit for the purchase of the new home is protected up to a maximum of \$50,000 in the event the deposit becomes legally refundable and cannot be recovered due to insolvency or default on the part of the Builder Member. Deposit coverage does not cover reimbursement because of a contractual dispute between the parties.

#### ONE YEAR WORKMANSHIP AND MATERIALS COVERAGE

Builder Members are required to warrant that the home is constructed in accordance with the building standards prescribed by the National Building Code of Canada as amended by the Province of Saskatchewan, Saskatchewan New Home Warranty's "Construction Performance Guidelines" and that the home is free from defects in workmanship and materials for a period of one year from the original date of possession.

#### TWO YEAR WATER PENETRATION COVERAGE

Builder Members warrant that the building envelope (roof, exterior cladding, windows and doors) and the basement foundation walls will be free of exterior water penetration for two years from original date of possession.

#### 10 YEAR MAJOR STRUCTURAL DEFECTS COVERAGE

Builder Members warrant that the home will be covered against Major Structural Defects for ten years from the original date of possession. Major Structural Defects mean defects in workmanship or material used in the construction of a new home that results in the failure of a load bearing component. Basement floor slabs, driveways, and walkways are not considered load bearing components.
